Completing the Form with Remote Electronic Methods

Candidates should complete the upper portion of the form, print and sign, make copies or scan to save as PDF.

Candidates should mail or email the filled-out petition forms to their contacts who are enrolled Samish over age 18, request they print, add their name and signature, mail signed form back to the candidate or scan and email back to the candidate.

Candidates should collect sufficient mailed or emailed signed Declaration and Affidavit of Candidacy petitions from enrolled Samish citizens to document ten signatures.

Candidates should mail a complete packet of all signed petitions so it is received no later than 5 pm May 7, 2024 to:
