SUBJECT: COVID-19 Statutory and Regulatory Waiver Authority

Dear Tribal Leader:

On April 10, 2020, the U.S. Department of Housing and Urban Development (HUD) issued Notice PIH 2020-05. Pursuant to the authority provided under the Coronavirus Aid, Relief, and Economic Security (CARES) Act (Public Law 116-136), HUD is waiving and establishing alternative requirements for numerous statutory and regulatory requirements for the Indian Housing Block Grant (IHBG) program and the Indian Community Development Block Grant (ICDBG) program. These waivers provide administrative flexibilities and relief to Indian tribes and tribally designated housing entities (TDHEs) in response to the COVID-19 pandemic. Last week, HUD published the allocations for IHBG funding under the CARES Act (IHBG-CARES funding), which is available at: <https://www.hud.gov/sites/dfiles/PA/documents/IHBGchart.pdf>. In the near future, HUD will issue an implementation notice that will detail an abbreviated process for accessing IHBG-CARES funding to prevent, prepare for, and respond to the effects of the COVID-19 pandemic. In addition, HUD will issue an implementation notice that will detail applying for ICDBG-Imminent Threat funding under the CARES Act (ICDBG-CARES funding).

HUD is committed to supporting tribal governments nationwide in addressing the effects of COVID-19 on their communities during this public health crisis.
